

Noll also currently serves as the Secretary for the Wisconsin Law Enforcement Canine Handler Association (WLECHA); an association that aims to assist Law Enforcement K9's across the State of Wisconsin and has over 200 active members. In 2012, K9 Axel and Mike were recognized by the Wisconsin Law Enforcement Canine Handlers Association (WLECHA) as Rookie Handler of the Year. Mike was promoted to Patrol Sergeant in 2013 and then to Jail Administrative Captain in 2016, continuing to work alongside K9 Axel while taking on new leadership roles and mentoring staff across multiple divisions.

That same year, the team received WLECHA's Handler of the Year award, marking a remarkable milestone for both the program and the department. It was also a proud year for Marquette County, as Sgt. Noll and K9 Blackjack earned Rookie Handler of the Year, showcasing the strength of the county's K9 program. K9 Axel officially retired in August 2022 after more than a decade of dedicated service.

Throughout his career, Mike has served in a wide range of roles, including Field Training Officer, Certified LESB Instructor, Correctional Officer, Patrol Deputy, Patrol Sergeant, Jail Administrator, Captain of Field Operations, and Police Chief for the Village of Oxford. He is a graduate of the Wisconsin Command College (Class 4) and the FBI National Academy (Class 271). Mike also holds certifications as a Certified Public Manager and Certified Jail Manager through the American Jail Association.

III. Roll Call by Secretary John Tobin

Secretary John Tobin called the roll of paid member Crime Stoppers programs. The following programs were present - see Roll Call List.

IV. Reading of the Minutes of Annual Business Meeting, 10/28/23 by Secretary John Tobin

The minutes of the last Annual Business Meeting which occurred on 10/28/23 were included in the conference packet. Hans Lux made a motion to approve the minutes as presented in the conference packet; Mike Kowalski seconded and it passed without dissent. Motion approved.

V. Annual Treasurer's Report by Treasurer Penny Weber

Treasurer, Penny Weber, presented the annual treasurer's report for the calendar year 2023. The treasurer's report was included in the conference packet.
