KC MURDER REWARDS UP TO \$10K!

On the morning of April 27th, The Kansas City Metropolitan Crime Commission's Crime Stoppers TIPS Hotline and the Kansas City, Missouri Police Department jointly announced that a new program was being initiated to try to solve more of the city's murders. They released to the media that any tip coming in to Crime Stoppers that solves a murder in Kansas City, Missouri will be eligible for a cash reward of up to \$10,000. Previously the reward for solving a KC, MO murder was up to \$5,000.

approved a reward of the full \$10,000 for the person who gave the tip.

Whether by email, phone or our new P3 mobile app, all tips that come in to Crime Stoppers are completely anonymous. No caller ID or any other information is taken about the tipster. Even the cash rewards are paid in such a way that Crime Stoppers never learns the identity of the tipster. In its 36 years of service to the community, no Crime Stoppers caller has ever been identified.

That same night, a murder occurred near 107th and Blue Ridge in south KC. Within two hours, tips began to come in. The next afternoon a tip was received that led to the arrest of the suspected killer. The Crime Stoppers board of directors
