## \$23,000 REWARD IN KC COLD CASE



On July 23rd, 2014, at about 9 p.m., witnesses heard shouts and the sound of shots coming from the area of Bannister Road and James A. Reed in south KC.

When police arrived they found that 43 year-old Adrian Reed in his car. He had been shot several times and died from his wounds. No motive or suspect has yet been identified in this cold case murder.

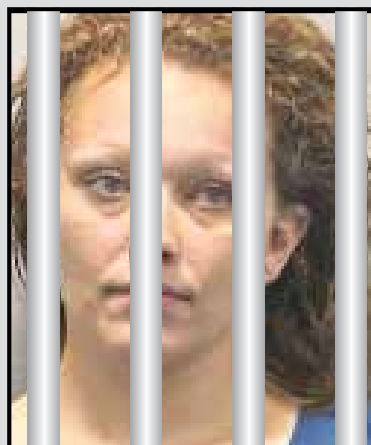
