II. Donation Instructions

1. ***Complete This Donation Agreement Form.*** Donations will not be accepted unless they are accompanied by this completed Donation Agreement Form.

2. ***Keep a Copy of the Donation Agreement Form for your Records.*** Due to the urgent nature of this case and the associated administrative difficulties, you will not receive a receipt or any other acknowledgment of your donation. It is your responsibility to maintain a copy of the completed Donation Agreement Form for your records.

3. ***Use a Check to Donate.*** Donations will not be accepted unless they are made by check or wire transfer. Checks must be made out to:

4. ***Mail Check and Completed Form.*** Donations will not be accepted unless they are made by check or wire transfer and accompanied by this completed Donation Agreement Form. III. Legal Information

1. This Donation Agreement Form is a binding contract between the donor and Crime Stoppers of Central Iowa (hereinafter “Crime Stoppers”). Crime Stoppers agrees to use donated funds solely for the purposes set forth in this Donation Agreement Form.

2. All donations properly made using the instructions in this Donation Agreement Form (hereinafter “the Reward Money”) will be deposited in an account titled Bring Mollie Tibbetts Home Safe Reward Fund at First State Bank, PO Box 532, 104 Jackson St., Brooklyn, IA 52211.

3. If information is provided to Crime Stoppers, the family of Mollie Tibbetts, or authorized law enforcement prior to August 1, 2020, and if this information leads to Mollie Tibbetts' safe return, Crime Stoppers will transfer the entirety of the Reward Money to the person providing the information.

4. If no information leading to Mollie Tibbetts' safe return is provided to Crime Stoppers, the family of Mollie Tibbetts, or authorized law enforcement by August 1, 2020, the Reward Money will automatically be disbursed to Mollie Tibbetts' family and/or Crime Stoppers, **unless** the donor signing this form checks the box below and complies with all further instructions in this paragraph. If the box below is checked, First State Bank will hold the donor's donation until **November 1, 2020**. The donor's donation will be returned only if the person signing this Donation Agreement Form and checking the box below then requests these funds from First State Bank and presents First State Bank with full proof of identity no later than **November 1, 2020**. If First State Bank has not **received** a request for a donation return along with legally sufficient proof of identity on or before **November 1, 2020**, the donation will automatically be disbursed to Mollie Tibbetts' family and/or Crime Stoppers.

By checking this box, the donor states that they wish to have their donation returned rather than donated to the Tibbetts family and/or Crime Stoppers in the event the conditions leading to the disbursement of the Reward Money have not been met by August 1, 2020. The donor further states that by checking this box, they have read the instructions in the above paragraph of this Donation Agreement Form, and they understand that to have their funds returned, they must comply with all instructions in the above paragraph of this Donation Agreement Form.

5. The donor signing this Donation Agreement Form agrees that Crime Stoppers has the authority to determine whether information provided qualifies as "leading to Mollie Tibbetts' safe return" such that the information would qualify for the Reward Money.

6. If the donor wishes to keep their donation anonymous, the donor must check the box below. If this box is not checked, the donor's donation will not remain anonymous. If the box is checked, the donor's donation will not be disclosed to the Tibbetts family or the public unless necessary to comply with a lawful court order or law enforcement instruction.

By checking this box, the donor states that they wish to remain anonymous.
